### Please read the below information regarding the Government changes to term time holiday fines.

### Penalty Notice Fines for School Attendance are changing from 19<sup>th</sup> August 2024

With the introduction of the new National Framework for Penalty Notices issued by DfE, the following changes will come into force for School Penalty Notice Fines issued after 19<sup>th</sup> August 2024.


### National Threshold

There will be a single consistent national threshold for when a penalty notice must be considered by all schools in England of 10 sessions (usually equivalent to 5 school days) of unauthorised absence within a rolling 10 school week period.

These sessions do not have to be consecutive and can be made up of a combination of any type of unauthorised absence.

The 10-school week period can span different terms or school years.

Please note: The DfE does not consider a need or desire for a holiday or other absence for the purpose of leisure and recreation to be an exceptional circumstance.



The first time a Penalty Notice is issued for unauthorised absence the amount will be:

£160 per parent, per child paid within 28 days.

Reduced to £80 per parent, per child if paid within 21 days.



The Second time a Penalty Notice is issued for unauthorised absence the amount will be:

£160 per parent, per child paid within 28 days.

### Per Parent\*, Per Child

Penalty Notice Fines are issued to each parent\*, for each child that was absent.

For example: 3 siblings absent for term time leave, would result in each parent receiving 3 separate fines.

### \*Parent


Section 576 of the Education Act 1996 defines "parent" as:

- All natural (biological) parents, whether they are married or not.
- Any person who, although not a natural parent, has parental responsibility for a child or young person.
- Any person who, although not a natural parent, has care of a child or young person.

### Third Offence and Any Further Offences (within 3 years)

The third time an offence is committed a Penalty Notice will not be issued and the case could be presented straight to the Magistrate's Court. Prosecution can result in Criminal records and fines of up to £2,500

Cases found guilty in Magistrates' Court may show on the parent's future DBS certificate due to 'failure to safeguard a child's education'.

# Starting secondary school in September 2025

## Why not apply for a place online?

If your child is due to start secondary school in 2025 then you will have to apply for a school place before 31 October 2024.

You **MUST** complete an application form either online at **www.dudley.gov.uk/admissions** or by completing the application form provided by your home local authority. You can include six school preferences on the application form; there is nothing to gain by only putting one preference.

### **Benefits of applying online**

- · E-mail decision received by 2pm on day of offer
- · It's quick and easy to use
- · You can apply 24 hours a day, 7 days a week
- · There's no risk that your application will be lost in the post
- · You will get email confirmation that your application has been received
- It's safe and secure

The online system will be available 24 hours a day, 7 days a week from 1 September 2024 until the closing date for applications on **31 October 2024**.

You should not assume that your child will get a place at a secondary school without you having to apply, even if you have an older child already attending the same school. This is a common misconception and often the biggest cause of disappointment for parents who believe otherwise.

# Early Collections

We would like to remind you that you should **NOT** be collecting your child early from the school office unless in exceptional circumstances. During the last school year, we had lots of parents/carers coming to collect their children early (between 2pm and 3:15pm) from the school office. Whilst we do appreciate that you may have a good reason to do this, it puts a huge strain on our staff. We understand that some parents have pre-agreed alternative collection arrangements due to exceptional circumstances which we wish to continue to support. As you know, we are a large school and it takes time to be walking children to and from the office and this is just not manageable due to not being able to leave the school reception unmanned. Please be aware therefore, that we may not be able to collect your child immediately for this and you may have to wait a while until we are able to fetch your child. Please remember that all parents/carers must provide notice in advance and with a relevant reason if you are collecting your child early from school. Please note you will be asked to provide proof of appointments. We apologise for this but I am sure you can imagine that it can become very unmanageable very quickly. Please don't hesitate to come and speak with us about this if you have any questions of concerns. Thanks for your continued support

### INFORMATION FOR PARENTS / CARERS -CLASS LISTS

Teachers are sometimes asked for class lists for birthday parties etc.

### Hair and Jewellery

No jewellery is allowed in school for safety reasons.

Only one pair of pierced small earrings with discrete colouring may be worn (that must be removed for PE) and a watch.

Any child who cannot remove their own earrings should come to school without them on PE days.

Any responsibility for lost/stolen or broken items cannot be accepted by the school.

Hairstyles must be reasonable and in sympathy with our school uniform. Extreme colours, patterns dyed into hair, spikes, shaving or sculpting is not

considered suitable for school and should be

reserved for holidays or weekends.

Long hair should be tied back for health and safety reasons, including at playtimes as there is play equipment in the playground.

<u>Water Bottles</u> - We encourage our children to bring water bottles into school. Drinking plenty of water keeps the body hydrated, which equals happy and bright children! Not only does it boost mental and physical performance, but water is vital to a child's development and general well-being, for a variety of reasons.

We have noticed a lot of children coming to school with highly-concentrated squash and juice. Consuming too many sugary drinks and fruit juices can lead to dental problems. Water is kind to little teeth, and helps keep them healthy and strong.

Please encourage your children to bring water to school and NOT squash. Water helps the brain to function, keeps children energised, and boosts concentration, which can all help our clever children excel in the classroom.
